You will need to re-apply to commence in a different intake. Full Fee-paying students can apply to defer or transfer prior to the Census date.

**Student Concession Card:**

Transferring students: Student Concession Cards are for full-time Diploma students only so if you are transferring from full-time to part-time studies, please hand in your card.

If your application to defer is approved, you **cease to be a student of College of Event Management** for the interim period and you are no longer eligible to use the card. You will be reissued with a new card when you take up your deferred position if the relevant conditions of enrolment apply at that time.

**Documentation:**

**Important Information:**

- Only one transfer or deferment per student is allowed
- Deferred positions must be reinstated within 12 months of approval (maximum 2 intakes)

Students who have deferred are not automatically enrolled into the next intake. You are required to nominate your preferred intake and attend an interview prior to taking up your deferred position
